2. BHDS rights:

- a. The Bidders participating in the tender will invariably be accepting all the terms and conditions of the tender. Non-compliance to any terms and conditions may cause rejection of the bid
- b. In case, any confusion/dispute occur due to different interpretation of the statement mentioned in the tender document, the decision of the Mission Director, BHDS shall be final and binding upon all concerned parties.
- c. BHDS reserves the right to increase or decrease the quantity, negotiate, accept, or reject the proposal without assigning any reason thereof.
- d. The evaluation committee may negotiate with the price of L1, if needed in the interest of farmers. The negotiated price after approval of competent authority will be final and applicable to the respective districts of Bihar under mentioned schemes.
- e. Evaluation will be done according to the terms and conditions cited in proposal documents under the governance of BFR, 2005.

- f. Payment will be done under DBT programme only after verification of the beneficiary unit by the Concerned ADH. The Payment will be released into two installments (90:10). First after supply and installation of unit and second after the submission of satisfactory report by the beneficiary. The admissible subsidy will be released through CFMS portal by the ADH concerned.
- g. Notwithstanding anything contained in the RFP, Mission Director, BHDS, Patna, reserve the right to accept or reject any proposal and annul the empanelment process and reject all proposals at any time without any liability or any obligation for such acceptance, rejection or annulment and without assigning any reasons thereof.
- h. The Mission Director BHDS, Patna also reserves the right to reject any or all proposals if:
 - At any time, a material misrepresentation is made or uncovered: or, the bidders do not provide, within the specified time, the supplemental information/any additional information it may find necessary or require clarifying, supplement or authenticate the Bid sought by Mission Director Horticulture, Bihar, Patna. Any request for clarification (s) and all clarification (s) on response thereto shall be in writing.
- i. For any query/ confusion related to the tender document must be asked in the pre-bid meeting. The pre-bid document proceeding will be the part of the tender document. Any query/ concern raised after the pre-bid query date will not be entertained.

3. Evaluation:

- 3.1 Prior to evaluation of Proposals, the BHDS will determine whether each Proposal is responsive to the requirements of the RFP. A Proposal shall be considered responsive only if:
 - a) It is received in the specified format.
 - b) It is received by the due date including any extension thereof.
 - c) It contains all the information (complete in all respects) as requested in the RFP.
 - d) It does not contain any conditions.
 - e) It has paid Rs. 50,000/- (Rupees Fifty Thousand) as Earnest Money Deposit (EMD) only through online mode (NEFT/RTGS)

The proposal not found responsive to the requirements of the RFP, shall be rejected.

- 3.2 Technical Evaluation: The Technical Proposals will be opened first and will be evaluated by the evaluation committee constituted at the society. Evaluation of the technical proposal shall be carried out by a committee constituted by the Society, which shall look into Eligibility criteria, compliance of specifications and other Terms & conditions for Empanelment. Only those bidders qualifying through the Technical Bid will be considered for financial evaluation.
- 3.3 Financial Evaluation: At the second stage, Financial Proposal of only technically acceptable agency will be opened, for further evaluation.
- 3.4 Empanelment of Agency: Agencies who will agree to provide service at L1 (Lowest financial quote will be only empaneled).
- 3.5 **Empanelment duration:** The empanelment of agencies would be for 3 years (2024-25, 2025-26 and 2026-27).
- 3.6 Empanelment fee: The empaneled agency will have to deposit Rs. 25,000/- (Twenty-Five Thousand Rupees Only), which will be non-refundable. It would be essential only for those technically qualified agencies who agreed to be empaneled with BHDS. The mode of deposit of empanelment fee would be NEFT/ RTGS/ Demand Draft.

4. General Terms & Conditions for Empanelment: -

- 1. It will be mandatory for the Agency to perform all the jobs as assigned in the scheme during installation of the Roof Top Gardening on beneficiary pucca roof for successful running of that garden throughout one year.
- 2. Manufacturer/ Authorized Dealer/ Firms/ Agency/ Govt. & Semi Govt. Organization/ Companies applying for empanelment should have at least 01 Year experience in the field of gardening or landscaping or roof top horticulture or supplying/installation of the concerned components as per their proposal for empanelment. Work order/ experience certificate issued from Govt/ or Semi-Govt. Organization should be attached with proposal in support of experience, which clearly indicated firm's name and volume supplied with component wise unit price & payment.
- 3. The following papers/documents must be attached with Proposal
 - Registration Certificate and detailed information of Factory, Firm/Company etc. as well as product catalogue of Manufacturer/Authorized Dealer/ Firms/ Agency/ Govt. Organization/ Company shall be attached with EOI.
 - b. Certificate issued by manufacturer being authorized dealer as well as registration certificate or organization and product catalogue must be attached with proposal.
- 4. Proposal submitted without relevant papers/documents will be rejected.
- 5. The firm should have its own manufacturing unit, Plant and Machinery etc. and authorized dealer should have proper authorization of concerned manufacturers or having authorized dealer point.
- 6. The annual turnover of the firm must be Rs. 5.00 lakh for two years. For the annual turnover balance sheet and Profit & Loss along with annual report and I.T. return should be submitted as supporting documents for two financial year (2022-23 & 2023-24)
- 7. The firm should furnish a copy of GSTIN registration number and GST return receipt of two financial year (2022-23 & 2023-24) with proposal.
- 8. The successful agency should have to submit annual empanelment fee of Rs. 25,000/- (Twenty-Five thousand) in the form of demand draft payable to **Mission Director**, **Bihar Horticulture**Development Society, Patna. The annual empanelment fee is nonrefundable.
- 9. Manufacturing unit/authorized dealer point may be inspected before approval as and when Mission Director, BHDS feel necessary to ensure the performance and quality of the product.
- 10. In the event of any complaint regarding after sales service and in case of supply of defective/substandard material, the empaneled firm shall have to rectify the defects within a period of 15 days.
- 11. The BHDS is free to evolve strong punitive measure against empaneled companies to safeguard the interest of beneficiaries in order to ensure proper utilization of public funds.
- 12. The material should be as per the quantity and quality as specified in the list of components under Roof Top Gardening. Failure to supply as per the specified quantity & quality shall result in the forfeiture of EMD, blacklisting and legal action against the company.
- 13. Earnest Money Deposit (EMD) of Rs. 50,000/- (Fifty Thousand) and document fee of Rs 1000/- (One thousand rupees only) should be Pay in online mode (NEFT/RTGS/CHALLAN) will be mandatory. The earnest money of the technically unsuccessful firms will be refunded after the rejection of their Proposal and will be retained from the successful firms up to the time of execution of contract, till the submission of security deposit and signing of agreements.
- 14. **Performance Security Deposit:** The Successful agency should have to deposit an amount of 5% (Incl. GST) of the quoted project cost as performance security money in the form of Bank Draft/ Bank Guarantee/NEFT/RTGS (issued by nationalized bank only) in favor of Mission

- Director, Bihar Horticulture Development Society payable at Patna, Bihar. The Security amount will be/Shall be forfeited if the party/firm/company/organization fails to provide services i.e. installation, maintenance in stipulated time
- 15. EMD will be the part of technical proposal. Without EMD submission, any Firms/Agency technical document will not be evaluated.
- 16. All the **proposal** documents should be signed by the **authorized person**, **carrying the prescribed letter of authority** and his full name and status should be indicated below his signature with the seal of agency/ company/ firm.
- 17. Conditional proposal will not be accepted.
- 18. No claim will be entertained afterwards for any increase in the market price or otherwise.
- 19. Every firm/Agency have a pool of 2-3 Gardener for maintenance of Roof Top Gardening of individual beneficiaries as per demand. Gardener name with agency engagement must declare on empanelment.
- 20. Every Firm/Agency, who empanel have to ensure minimum 18 visit to individual beneficiaries after installation of Roof Top Gardening in a year.
- 21. The proposal for empanelment will be opened and will be evaluated by the evaluation committee at the society. Only such proposal will be evaluated in which required Earnest Money and Proposal document cost are deposited along with the Proposal and that meets other conditions of the proposal. Evaluation of the Proposal shall be carried out by a committee constituted by the Society, which shall look into compliance of specifications and of other conditions of PROPOSAL enquiry.
- 22. An agreement on non-judicial stamp of Rs. 1000.00 would be made mandatory for functional working to make available/installation of any component mentioned in Proposal between Mission Director, Bihar Horticulture Development Society and concerned Firm/Agency Authorized Person on followings points: -
- i. The companies shall have to be make available material at the Roof Top of Beneficiaries of the state as per terms and conditions mentioned in agreement. No other charges such as octroi, packing, forwarding, freight, insurance, loading and unloading, clearance etc. will be allowed.
- ii. The purchaser and the agency shall make every effort to resolve amicably by direct negotiation, in case of any disagreement or dispute arising between them under or in connection with the purchase, shall be settled under the Court of Law within its jurisdiction at concerned district head quarter.
- iii. The agencies shall have the full responsibility so far as the final work orders given by ADH in this regard to beneficiaries.
- iv. Component's material should be as per the quantity and quality as specified in the list of components under Roof Top Gardening (Annexure IV & IV (A)). Failure to supply as per the quantity and quality as specified shall result for forfeiture of EMD, blacklisting and legal action against the agencies.
- 23. Payment against Bill/Voucher invoice shall be done under DBT (Direct Benefit Transfer) program only. No interest will be payable on the delayed payment. If any complaint is received from beneficiary regarding quality of the material/components FOUND true after enquiry then security deposit if any will be seized and shall result in forfeiture of EMD, blacklisting and legal action against the agency. BHDS will release admissible subsidy under DBT program only on the basis of total quantity found with the beneficiary during physical verification.

- 24. Mission Director, BHDS Patna reserves the right to reject/cancel the empanelment of firm at any time if he/she is satisfied that it is desirable to do so in beneficiary's interest The decision of Mission director, BHDS, Patna shall be final and binding.
- 25. The Bihar Horticulture Development Society reserves the right to accept /revise /change or reject any proposal or all at any time without assigning any reason thereof.
- 26. Any legal dispute if arises, will be settled at Patna jurisdiction only.

5. Disqualification

The reasons for the disqualification of the participating agencies are mentioned below:

- a. The quotations/response to the e-tender submitted/received after due date/time will be summarily rejected.
- b. The interested entity has made misleading or false representation in the firms, statements, attachments submitted in proof of eligibility.
- c. The e-tender is not accompanied by required document
- d. The interested entity fails to provide clarification related thereof, when sought.
- e. The firm/company should provide/give the correct and true information while submitting the tender. In case of incorrect/false information found at any stage, the tender/bid will be cancelled, and legal action will also be initiated.
- f. The interested Entity is found to canvass, influence, or attempt to influence in any manner, the qualification or empanelment process will be disqualified.
- g. Notwithstanding anything written above or elsewhere, the e-tender may disqualify the Interested Entity without assigning or disclosing any reason thereof.
- h. Any change in the Annexure format specified in the RFP/E-proc2, may cause rejection of the bid.

➤ Note- This scheme will be implemented in four districts of Bihar i.e. Patna, Gaya, Muzaffarpur, Bhagalpur. Under this scheme per unit 03 portable farming beds, 02 organic kits, 06 feet bag (24"x24") including fruit plant, 5 round spinach growing bag (24"x24"), drain cell (120 sq.ft.), Sapling Tray (1 tray per season- in all three seasons),1 hand sprayer, 1 hoe, drip installation with motor and bucket will be done. The facility of weeding, hoeing & irrigation of the farming bed will be done 02 times per month (at an interval of 15 days) per unit by the selected agency.
