Short E-Tender Notice for Empanelment of agencies/firms for Supply, Installation, Commissioning and Maintenance of Equipment/Machineries for FPC Established under BHDS in Multiple Districts of Bihar.

For timely and smooth execution of different schemes of horticulture development in 2024-25 in the state of Bihar, Bihar Horticulture Development Society (BHDS), Patna, Bihar invites Tender for supply/installation of the materials/machines required to install machinery, packaging material, along with supply of GHP (Good hygienic practices & protection kit) material to assure the availability to the beneficiary for execution of BHPD Scheme at 19 locations in Bihar. Agencies should have own manufacturing/supply or distributor/dealership with proper certification and should also have facilities of fundamental infrastructure in Bihar for storage and post installation service of materials mentioned in detail in this tender document.

E-tender forms including terms and conditions for technical qualification, specifications and procedure is available on website: https://eproc2.bihar.gov.in. Applicants may upload/submit their tender along with all required documents for technical qualification through the online portal https://eproc2.bihar.gov.in. Financial proposals should also be proposed on that portal in prescribed form separately.

2. BHDS rights:

- a. The Bidders participating in the tender will invariably be accepting all the terms and conditions of the tender. Non-compliance to any terms and conditions may cause rejection of the bid.
- b. In case, any confusion/dispute occur due to different interpretation of the statement mentioned in the tender document, the decision of the Mission Director, BHDS shall be final and binding upon all concerned parties.
- c. BHDS reserves the right to increase or decrease the quantity, negotiate, accept, distribute the order among two or more agencies or reject any or all the proposal without assigning any reason thereof.
- d. The evaluation committee may negotiate with the price of L1, if needed in the interest of farmers. The negotiated price after approval of competent authority will be final and applicable to the whole State of Bihar under mentioned schemes.
- e. Evaluation will be done according to the terms and conditions cited in proposal documents under the governance of BFR, 2005.
- f. Cost of machinery will be paid under Shade programme only after verification of quality/quantity of machines.
- g. Notwithstanding anything contained in the RFP, Mission Director, BHDS, Patna, reserve the right to accept or reject any proposal and annul the selection process and reject all proposals at any time without any liability or any obligation for such acceptance, rejection or annulment and without assigning any reasons thereof.
- h. The Director Horticulture, Bihar, Patna also reserves the right to reject any or all proposals if:
 - i. At any time, a material misrepresentation is made or uncovered: or, the bidders do not provide, within the specified time, the supplemental information/any additional information it may find necessary or require to clarify, supplement or authenticate the Bid sought by Mission Director Horticulture, Bihar, Patna. Any request for clarification (s) and all clarification (s) on response thereto shall be in writing.
- i. For any query/ confusion related to the tender document must be asked in the pre-bid meeting. The pre-bid document proceeding will be the part of the tender document. Any query/ concern raised after the pre-bid query date will not be entertained.

3. Evaluation:

- 3.1 Prior to evaluation of Proposals, the BHDS will determine whether each Proposal is responsive to the requirements of the RfP. A Proposal shall be considered responsive only if:
 - a) It is received in the specified format.
 - b) It is received by the due date including any extension thereof.
 - c) It contains all the information (complete in all respects) as requested in the RfP.
 - d) It does not contain any conditions
 - e) It has paid Rs. 100,000/- (Rupees One Lakh Only) as Earnest Money Deposit (EMD) and tender fee of Rs. 5,000/- (Rupees five thousand Only) through online mode (NEFT/RTGS)

The proposal not found responsive to the requirements of the RFP, shall be rejected.

3.2 Technical Evaluation: The Technical Proposals will be opened first and will be evaluated by the evaluation committee constituted at the society. Evaluation of the technical proposal shall be carried out by a committee constituted by the Society, which shall look into Eligibility criteria, compliance of

specifications and other Terms & conditions for empanelment. Only those bidders qualifying through the Technical Bid will be considered for financial evaluation.

- 3.3 Financial Evaluation: At the second stage, Financial Proposal of only technically acceptable agencies will be opened, for further evaluation. Price for machines and equipment's will be discovered based on Least Cost Based System (LCBS).
 - 3.3.1 L1 would be considered as the final cost for per unit supply of machine and equipment's. The evaluation committee may negotiate with the price of L1 with technically qualified agencies if required in the interest of the farmers. Negotiated price after approval of competent authority will be final and applicable to the whole State of Bihar.
 - 3.3.2 Agencies who agreed to supply the machinery and equipment's on L1 or final negotiated price by the evaluation committee and approved by competent authority will be empanelled with the BHDS.
 - 3.3.3 BHDS has all rights to distribute work among empanelled agencies according to what is the best in the farmers' interest.

4. General terms and conditions for empanelment in BHDS: -

- 4.1 Empanelment fee will be Rs. 25,000/- for one year which will be non- refundable. It would be essential only for those technically qualified agencies who agreed to be empanelled with BHDS.
- 4.2 Proposal should be submitted only through online e-tender on website: https://eproc2.bihar.gov.in
- 4.3 Proposal submitted without relevant papers/documents will be rejected.
- 4.4 Telephone No./Mobile No./Email and Full Address of the applicant must be mentioned in proposer Information sheet (Annexure II)
- 4.5 The machinery shall have to be made available at the packhouse premises of different districts of the state. No other charges such as Octroi, Packing, Forwarding, Freight, Insurance, Loading and Unloading, Clearance etc. will be allowed.
- 4.6 In case of any disagreement or dispute arises, both parties shall make every effort to resolve the issues amicably by direct negotiation, If issue still persists, shall be settled under the Court of Law within its jurisdiction at Patna.
- 4.7 The agencies shall have the full responsibility to timely deliver the quality machinery and equipment's to BoDs/beneficiaries of the schemes as the final work orders being given by ADH. In this regard:
 - It will be mandatory for the applicant to perform all the jobs as assigned in the scheme during installation/Supply of processing equipment and machineries of pack house arrangement for successful running of project.
 - Performance security deposit if any to be required, can be forfeited in case of nonperformance of the contract and if time limits indicated in the work order are exceeded.
- 4.8 Names of manufacturing Centre and maintenance unit where machinery and equipment be produced or stored, Production capacity/available stock and variety should be clearly indicated in proposal documents and the society reserves the right to inspect these premises as well as Brand name/specification/warranty period of each component must be mentioned in proposal.
- 4.9 Machinery and equipment should be as per the quality specifications mentioned in the proposal documents. Failure to supply as per the quality specifications shall result in for forfeiture of EMD, blacklisting and legal action against the agencies.,
- 4.10The BHDS is free to evolve strong punitive measure against erring agencies to safeguard the interests of farmers in order to ensure proper utilization of public funds.
- 4.11In the event of any complaint regarding after sales service and in case of supply of defective/substandard material, the empanelled firm shall have to replace within a period of 15 days.
- 4.12The Technical Proposals shall consist of all technical details along with commercial terms and conditions and, Financial Proposals shall indicate unit price of the machineries and equipment.

- 4.13 Financial Proposal will be quoted in figures as well as in words. In case of any ambiguity in amount quoted in words will be considered final. Any correction of entries and over writing in entries may be rejected without any prejudice.
- 4.14EMD and document costs will be the part of Technical Proposal only.
- 4.15Tender document cost of INR 5000/-(**five thousand**) and EMD of INR **1 Lakh** through online mode NEFT/RTGS needs to be submitted on or before the opening of technical bids. Bid without tender documents cost and EMD will not be considered.
- 4.16EMD of the technically unsuccessful bidders will be refunded after the rejection of their **Proposal** and will be retained of the technically successful proposers till the submission of security deposit.
- 4.17The **Technical Proposal** along with all required documents for technically qualification should be uploaded/submitted through online e-tender on website https://eproc2.bihar.gov.in. Financial proposal should also be proposed on that portal in prescribed form separately.
- 4.18Price proposed in financial proposal must be inclusive of all taxes and freight for destination etc. at district FPC Packhouse location of concerned district. Financial Proposal will be quoted in figures as well as in words. As already mentioned, In case of any ambiguity in figure amount quoted in words will be considered. The price quoted of machinery and equipment must be with respect to desired technical specification mentioned in proposal documents.
- 4.19Conditional proposal will not be accepted.
- 4.20No claim will be entertained afterwards for any increase in market price or otherwise. Payment against Bill/Invoice shall be made only after the successful delivery (beneficiary farmers) consent through DBT programme by CFMS/PFMS portal only. **No interest will be payable on the delayed payment.**
- 4.21The agency shall submit an affidavit from notary that "the agency has not been blacklisted by any State Govt./Union Govt. and no legal issues regarding machinery material supply is pending in any court as well as the stock mentioned in the financial proposal is correct."
- 4.22 Participation for the empanelment process will automatically imply the acceptance, on all the terms and conditions of this notice for empanelment.
- 4.23 **Performance Security Deposit**: The successful agency should have to deposit an amount of 5% (incl. GST) of the quoted project cost as Performance security money in the form of Bank Draft/Bank Guarantee (Issued by nationalized bank only) in favor of the Mission Director, Bihar Horticulture Development Society payable at Patna, Bihar. The security amount will be/shall be forfeited if the party/firm/company/organization fails to provide services *i.e.* installation, maintenance in stipulated time.
- 4.24After award of the tender of the machines & Equipment in Pack House, the 50% payment will be provided to agency after supply of machine to FPC; rest 40% payment will be provided after installation and commencement of operation of machine and rest 10% of payment would be furnished 1 year post installation of machine and successful operation.
- 4.25 AMC-The empanelled agency shall provide the following services to keep the equipment in good working condition
 - i. It covers comprehensive on-site maintenance equipment and machineries for atleast one year of warranty coverage from the date of installation.
 - ii. Maintenance and repairing for any defects in spare parts during operations covered under warranty period for at least one year and will be the sole responsibility of the agency. After warranty period the agency will facilitate repairing and maintenance of machineries till the completion of three years and the expenses will be borne by the FPC.
 - iii. Replacement of defective parts will be covered under brand or agency guarantee or warrantee till the guarantee or warrantee mentioned period. Maximum 15 days periods will be given to resolve the machinery repairing or other issues.
 - iv. Faulty parts removed from the system belong to FPC. However, the company can retain the same and use at its own sole discretion to maintain the equipment subject to the payment of its value to the vendor/agency.
 - v. The empanelled and supplying firm shall maintain service center in the state of Bihar, shall maintain adequate spare machine and other spares at the site to facilitate any temporary replacement.
 - vi. Complaint regarding improper functioning, damage etc. can be registered either telephonically or by e-mail by respective branch/Office and proper record of the complaints to be maintained by the firm. The bidder to provide the one-point contact details of the SPOC (single point of contact) who shall be contacted in case of complaints related to machine and

- equipment. The firm shall carry out Preventive Maintenance (PM) on quarterly basis for next 01 years from the date of installation. In the event of any complaint regarding after sales service and in case of supply of Defective/substandard material, the empanelled firm shall have to rectify the defects within a period of 15 days.
- 4.25.1 Payment to the empanelled agency will be done on Joint Verification Report/ Inspection report attested and stamp by FPC Director and Assistant Director, Horticulture of the Concern District. Inspection Report should be submitted along with Geo Tagged Photograph, Challan and Original Invoice of the Equipment and Machines mentioned in the Tender.
- 4.25.2 In the event of any complaint in case of supply of defective/substandard Equipment and Machines not according to Tender Document, the empanelled firm shall have to replace within a period of 7 days or payment of such Equipment and Machines will be disallowed from final payment to empanelled agency.

5. Disqualification

The reasons for the disqualification of the participating firm/company/organization are mentioned below:

- a. The quotations/response to the e-tender submitted/received after due date/time will be summarily rejected.
- b. The interested entity has made misleading or false representation in the firms, statements, attachments submitted in proof of eligibility.
- c. The e-tender is not accompanied by required documentation.
- d. The interested entity fails to provide clarification related thereof, when sought.
- e. The firm/company should provide/give the correct and true information while submitting the tender. In case of incorrect/false information found at any stage, the tender/bid will be cancelled, and legal action will also be initiated.
- f. The interested Entity is found to canvass, influence or attempt to influence in any manner, the qualification or selection process, including without limitation, by offering e-tender or other illegal satisfaction.
- g. Notwithstanding anything written above or elsewhere, the e-tender may disqualify the Interested Entity without assigning or disclosing any reason thereof.
- Any change in the Annexure format specified in the RFP/E-proc2, may cause rejection of the bid.
