For the holistic development of horticulture in the state of Bihar, Directorate of Horticulture, Bihar, Patna invites e-tender from interested Govt./Semi Govt. organizations /Private Registered Tissue Culture Plant Producers having their own tissue culture laboratory accredited by the Department of Bio Technology (DBT), hardening units and facilities of basic infrastructures for **Selection** to ensure timely availability of quality Tissue Culture Anjeer (Fig) Planting Material on uniform price, as determined by the evaluation committee of Directorate of Horticulture, to the farmers of the state of Bihar. In determination of uniform price of Tissue Culture Plants for the state, financial proposals of the technically qualified agency may be taken under consideration.

## 2. Directorate of Horticulture rights:

- The Bidders participating in the tender will invariably be accepting all the terms and conditions of the tender. Non-compliance to any terms and conditions may cause rejection of the bid.
- In case, any confusion/dispute occur due to different interpretation of the statement mentioned in the tender document, the decision of the Director Horticulture shall be final and binding upon all concerned parties.**
- Directorate of Horticulture reserves the right to decrease the quantity, negotiate, accept, or reject the proposal without assigning any reason thereof.
- The evaluation committee may negotiate with the price of L1, if needed in the interest of farmers. The negotiated price after approval of competent authority will be final and applicable to the whole State of Bihar under mentioned schemes.
- Evaluation will be done according to the terms and conditions cited in proposal documents under the governance of BFR, 2005.
- Cost of plants will be paid under DBT programme only after **verification of quality/quantity of plants**. The admissible subsidy for the first year will be released through CFMS 2.0 portal by the ADH concerned.

- g. Notwithstanding anything contained in the RFP, Director Horticulture, Directorate of Horticulture, Patna, reserve the right to accept or reject any proposal and annul the selection process and reject all proposals at any time without any liability or any obligation for such acceptance, rejection or annulment and without assigning any reasons thereof.
- h. The Director Horticulture, Directorate of Horticulture Patna also reserves the right to reject any or all proposals if:
  - i. At any time, a material misrepresentation is made or uncovered: or, the bidders do not provide, within the specified time, the supplemental information/any additional information it may find necessary or require clarifying, supplement or authenticate the Bid sought by Director Horticulture, Bihar, Patna. Any request for clarification (s) and all clarification (s) on response thereto shall be in writing.
- i. **For any query/ confusion related to the tender document must be asked in the pre-bid meeting.** The pre-bid document proceeding will be the part of the tender document. Any query/ concern raised after the pre-bid query date will not be entertained.

### 3. Evaluation:

- 3.1 Prior to evaluation of Proposals, the Directorate of Horticulture will determine whether each Proposal is responsive to the requirements of the RFP. A Proposal shall be considered responsive only if:
  - a) It is received in the specified format.
  - b) It is received by the due date including any extension thereof.
  - c) It contains all the information (complete in all respects) as requested in the RFP.
  - d) It does not contain any conditions.
  - e) It has paid Rs. 25,000/- (Rupees Twenty-five thousand) as Earnest Money Deposit (EMD) through online mode (NEFT/RTGS)

The proposal not found responsive to the requirements of the RFP, shall be rejected.

**3.2 Technical Evaluation: The Technical Proposals will be opened first** and will be evaluated by the evaluation committee constituted at the Directorate of Horticulture. Evaluation of the technical proposal shall be carried out by a committee constituted by the Directorate of Horticulture, which shall look into Eligibility criteria, compliance of specifications and other Terms & conditions for Selection. **Only those bidders qualifying through the Technical Bid will be considered for financial evaluation.**

**3.3 Financial Evaluation:** At the second stage, **Financial Proposal of only technically acceptable agency will be opened**, for further evaluation.

**3.4 Selection of Agency: The agency with the L1 (Lowest) Financial quote will be selected.**

### 4. General terms and conditions for Selection in Directorate of Horticulture: -

- 4.1 Proposal should be submitted only through online e-tender on website: <https://eproc2.bihar.gov.in>
- 4.2 Proposal submitted without relevant papers/documents will be rejected.
- 4.3 Telephone No./Mobile No./Email and Full Address of the applicant must be mentioned in proposer Information sheet (Annexure II)
- 4.4 The plants shall have to be made available at the premises of districts of the state. No other charges such as Octroi, Packing, Forwarding, Freight, Insurance, Loading and Unloading, Clearance etc. will be allowed.
- 4.5 In case of any disagreement or dispute arises, both parties shall make every effort to resolve the issues amicably by direct negotiation, if issue still persists, shall be settled under the Court of Law within its jurisdiction at Patna.
- 4.6 The agency shall have the full responsibility to timely deliver the quality planting materials to beneficiaries of the schemes as the final work orders being given by ADH. In this regard:
  - Performance security deposit if any to be required, can be forfeited in case of non-performance of the contract and if time limits indicated in the work order are exceeded.

- 4.7 Names of Tissue Culture Laboratory Centre where plants will be produced/ Production capacity/available stock and variety should be clearly indicated in proposal documents and the society reserves the right to inspect these premises.
- 4.8 Tissue Culture Anjeer (Fig) Plant should be as per the quality specifications mentioned in the proposal documents. **Failure to supply as per the quality specifications shall result in forfeiture of EMD, blacklisting and legal action against the agencies.**
- 4.9 The Directorate of Horticulture is free to evolve strong punitive measure against erring agencies to safeguard the interests of farmers in order to ensure proper utilization of public funds.
- 4.10 The **Technical Proposals** shall consist of all technical details along with commercial terms and conditions and, **Financial Proposals** shall indicate unit price for T.C. Plant as well as production capacity of lab per month.
- 4.11 **Financial Proposal** will be quoted in figures as well as in words. In case of any ambiguity in amount quoted in words will be considered final. Any correction of entries and over writing in entries may be rejected without any prejudice.
- 4.12 **EMD** will be the part of Technical Proposal only.
- 4.13 **EMD** of INR **25,000** through online mode NEFT/RTGS needs to be submitted on or before the opening of technical bids. Bid without EMD will not be considered.
- 4.14 **EMD of the technically unsuccessful bidders will be refunded after the rejection of their Proposal** and will be retained of the technically successful proposers till the submission of security deposit.
- 4.15 The **Technical Proposal** along with all required documents for technical qualification should be uploaded/submitted through online e-tender on website <https://eproc2.bihar.gov.in>. Financial proposal should also be proposed on that portal in prescribed form separately.
- 4.16 **Price proposed in financial proposal must be inclusive of all taxes and freight** for destination etc. at district headquarters (FOR district head- quarters). Financial Proposal will be quoted in figures as well as in words. **In case of any ambiguity in figure amount quoted in words will be considered.** The price quoted of T.C. Plant must be with respect to desired technical specification mentioned in proposal documents. In financial proposal stock availability and capacity to supply per month of T.C Anjeer (Fig) Planting Material must be mentioned.
- 4.17 Conditional proposal will not be accepted.
- 4.18 No claim will be entertained afterwards for any increase in market price or otherwise. Payment against Bill/Invoice shall be made only after the purchasers (beneficiary farmers) consent through DBT programme by CFMS 2.0 portal only. **No interest will be payable on the delayed payment.**
- 4.19 **If any complaint is received from farmer regarding quality of the planting material and found correct after inspection then 10% amount of supplied planting material to concerned beneficiaries will be seized and shall result in forfeiture of EMD, blacklisting and legal action against the agency.**
- 4.20 Directorate of Horticulture will release admissible subsidy directly under DBT through CFMS 2.0 portal on the basis of the total number of plants found in the farmers plot during physical verification of the plot (subject to maximum mortality up to 5%).
- 4.21 The agency shall submit an affidavit from notary that **"the agency has not been blacklisted by any State Govt./Union Govt. and no legal issues regarding planting material supply is pending in any court as well as the stock mentioned in the financial proposal is correct."**
- 4.22 Participation for the Selection process will automatically imply the acceptance, on all the terms and conditions of this notice for Selection.
- 4.23 Quantum of planting material to be supplied would be decided on the basis of stock in the hardening Centre & capacity of the agency to supply per month as already declared by the agency in their financial proposal forms.
- 4.24 The uniform price fixed for the above-mentioned crop will be valid for three financial year (FY 2025-26, 2026-27 & 2027-28) only.
- 4.25 **Performance Security Deposit:** The successful agency should have to deposit an amount of 5% (**incl. GST**) of the quoted project cost as Performance security money in the form of Bank Draft/Bank Guarantee (Issued by nationalized bank only) in favor of the Director Horticulture, Directorate of Horticulture, Bihar payable at Patna, Bihar. The security amount will be/shall be forfeited if the party/firm/company/organization fails to provide services *i.e.*, installation, maintenance in stipulated time.

- 4.26 Selected agency has to ensure establishment of hardening center for supply and distribution of sapling materials.

## **5. Disqualification**

The reasons for the disqualification of the participating agencies are mentioned below:

- a. The quotations/response to the e-tender submitted/received after due date/time will be summarily rejected.
- b. The interested entity has made misleading or false representation in the firms, statements, attachments submitted in proof of eligibility.
- c. The e-tender is not accompanied by required documentation.
- d. The interested entity fails to provide clarification related thereof, when sought.
- e. The firm/company should provide/give the correct and true information while submitting the tender. In case of incorrect/false information found at any stage, the tender/bid will be cancelled, and legal action will also be initiated.
- f. The interested Entity is found to canvass, influence, or attempt to influence in any manner, the qualification or selection process, including without limitation, by offering e-tender or other illegal satisfaction.
- g. Notwithstanding anything written above or elsewhere, the e-tender may disqualify the Interested Entity without assigning or disclosing any reason thereof.
- h. Any change in the Annexure format specified in the RFP/E-proc2, may cause rejection of the bid.**
