Very Short e-Tender notice for the selection of agency to secure availability of Tissue culture produced Breeder/G-3 Potato (Lady Rosetta) seed during 2025-26 in the State of Bihar.

For the holistic development of horticulture in the state of Bihar, Bihar Horticulture Development Society (BHDS), Bihar, Patna invites very short e-tender from interested Govt./Semi Govt. organizations / Registered Private Tissue Culture Producers having their own tissue culture laboratory accredited by the Department of Bio Technology (DBT) or their dealers, hardening units and facilities of basic infrastructures for **empanelment** to ensure timely availability of quality Tissue Culture produced Breeder/G-3 Potato (Lady Rosetta) seed on uniform price, as determined by the evaluation committee of BHDS, to the farmers of the state of Bihar. In determination of uniform price of Tissue culture produced Breeder/G-3 Potato (Lady Rosetta) seed for the state, financial proposals of the technically qualified agencies may be taken under consideration.

E-tender forms including terms and conditions for technical qualification, specifications, as well as quality and quantity of T.C. produced breeder seeds and procedure is available on website: horticulture.bihar.gov.in/_https://eproc2.bihar.gov.in. Applicants may upload their tender along with all required documents for technical qualification through the online portal https://eproc2.bihar.gov.in. Financial proposals should also be proposed on that portal in prescribed form separately.

2. BHDS rights:

- a. The Bidders participating in the tender will invariably be accepting all the terms and conditions of the tender. Non-compliance to any terms and conditions may cause rejection of the bid.
- b. In case, any confusion/dispute occur due to different interpretation of the statement mentioned in the tender document, the decision of the Mission Director, BHDS shall be final and binding upon all concerned parties.
- c. BHDS reserves the right to increase or decrease the quantity, negotiate, accept, distribute the order among two or more agencies or reject any or all the proposal without assigning any reason thereof.
- d. The evaluation committee may negotiate with the price of L1, if needed in the interest of farmers. The negotiated price will be final and applicable to the whole State of Bihar under mentioned schemes.
- e. Evaluation will be done according to the terms and conditions cited in proposal documents under the governance of BFR, 2005.
- f. Cost of seeds will be paid under DBT programme only after **verification of quality/quantity of seeds**. The admissible subsidy will be released by the ADH/DHO's concerned.
- g. Notwithstanding anything contained in the RFP, Mission Director, BHDS, Patna, reserve the right to accept or reject any proposal and annul the selection process and reject all proposals at any time without any liability or any obligation for such acceptance, rejection or annulment and without assigning any reasons thereof.
- h. The Mission Director, BHDS, Patna also reserves the right to reject any or all proposals if:
 - i. At any time, a material misrepresentation is made or uncovered: or, the bidders do not provide, within the specified time, the supplemental information/any additional information it may find necessary or require to clarify, supplement or authenticate the Bid sought by Mission Director, BHDS, Patna. Any request for clarification (s) and all clarification (s) on response thereto shall be in writing.
- i. For any query/ confusion related to the tender document must be asked in the pre-bid meeting. The pre-bid document proceeding will be the part of the tender document. Any query/ concern raised after the pre-bid query date will not be entertained.

3. Evaluation:

- 3.1 Prior to evaluation of Proposals, the BHDS will determine whether each Proposal is responsive to the requirements of the RFP. A Proposal shall be considered responsive only if:
 - a) It is received in the specified format.
 - b) It is received by the due date including any extension thereof.
 - c) It contains all the information (complete in all respects) as requested in the RFP.
 - d) It does not contain any conditions
 - e) It has paid Rs. 5,00,000/- (Rupees Five Lakh Only) as Earnest Money Deposit (EMD) and tender document cost of Rs. 5,000/- (Rupees five thousand Only) through online mode (NEFT/RTGS only)

The proposal not found responsive to the requirements of the RFP, shall be rejected.

- 3.2 Technical Evaluation: The Technical Proposals will be opened first and will be evaluated by the evaluation committee constituted at the society. Evaluation of the technical proposal shall be carried out by a committee constituted by the Society, which shall look into Eligibility criteria, compliance of specifications and other Terms & conditions for empanelment. Only those bidders qualifying through the Technical Bid will be considered for financial evaluation.
- 3.3 Financial Evaluation: At the second stage, Financial Proposal of only technically acceptable agencies will be opened, for further evaluation. Price for varieties of T.C. produced Breeder/G-3 Potato (Lady Rosetta) seed varieties will be finalized on the basis of Least Cost Based System (LCBS).

- 3.3.1 L1 would be considered as the final cost for per unit for TC Produced Breeder/G-3 Potato (Lady Rosetta) seed. The evaluation committee may negotiate with the price of L1 with technically qualified agencies if required in the interest of the farmers. Negotiated price will be final and applicable to the whole State of Bihar.
- 3.3.2 Agencies who agreed to supply the tissue culture Breeder/G-3 Potato (Lady Rosetta) seed on L1 or final negotiated price by the evaluation committee will be empaneled with the BHDS.
- 3.3.3 BHDS has all rights to distribute work among empaneled agencies according to what is the best in the farmers' interest and on the basis of area of the hardening centre.

4. General terms and conditions for empanelment in BHDS: -

- 4.1 Empanelment fee will be Rs. 25,000/- for one year which will be non- refundable. It would be essential only for those technically qualified agencies who agreed to be empaneled with BHDS.
- 4.2 Proposal should be submitted only through online e-tender on website: https://eproc2.bihar.gov.in
- 4.3 Proposal submitted without relevant papers/documents will be rejected.
- 4.4 Telephone No./Mobile No./Email and Full Address of the applicant must be mentioned in proposer Information sheet (Annexure II)
- 4.5 The plants shall have to be made available at the premises of different block of the state. No other charges such as Octroi, Packing, Forwarding, Freight, Insurance, Loading and Unloading, Clearance etc. will be allowed.
- 4.6 The tender evaluation and quoted rates will be valid for FY 2025-26.
- 4.7 In case of any disagreement or dispute arises, both parties shall make every effort to resolve the issues amicably by direct negotiation, If issue still persists, shall be settled under the Court of Law within its jurisdiction at Patna.
- 4.8 The agencies shall have the full responsibility to timely deliver the quality seeds to beneficiaries of the schemes as the final work orders being given by ADH/DHO. In this regard:
 - Performance security deposit if any to be required, can be forfeited in case of nonperformance of the contract and if time limits indicated in the work order are exceeded.
- 4.9 Names of Tissue Culture Laboratory Centre where plants will be produced/ Production capacity and variety should be clearly indicated in proposal documents and the society reserves the right to inspect these premises.
- 4.10 BHDS reserves the right to conduct random sampling up to 10% of supplied seeds in seed testing labs anywhere in India, before payment.
- 4.11 Tissue Culture produced Breeder/G-3 Potato (Lady Rosetta) seed should be as per the quality specifications mentioned in the proposal documents. Failure to supply as per the quality specifications shall result in for forfeiture of EMD, blacklisting and legal action against the agencies.
- 4.12 The BHDS is free to evolve strong punitive measure against erring agencies to safeguard the interests of farmers in order to ensure proper utilization of public funds.
- 4.13 The **Technical Proposals** shall consist of all technical details along with commercial terms and conditions and, **Financial Proposals** shall indicate variety wise unit price for T.C. seeds as well as production capacity of lab per month.
- 4.14 **Financial Proposal** will be quoted in figures as well as in words. In case of any ambiguity in amount quoted in words will be considered final. Any correction of entries and over writing in entries may be rejected without any prejudice.
- 4.15 **EMD and tender document costs** will be the part of Technical Proposal only.
- 4.16 Tender document cost of INR 5000/-(**five thousand**) and EMD of INR **5 Lakh** through online mode NEFT/RTGS needs to be submitted on or before the opening of technical bids. Bid without tender documents cost and EMD will not be considered.

- 4.17 EMD of the technically unsuccessful bidders will be refunded after the rejection of their Proposal and will be retained of the technically successful proposers till the submission of security deposit.
- 4.18 The **Technical Proposal** along with all required documents for technically qualification should be uploaded/submitted through online e-tender on website https://eproc2.bihar.gov.in. Financial proposal should also be proposed on that portal in prescribed form separately.
- 4.19 Price proposed in financial proposal must be inclusive of all taxes and freight for destination etc. at block headquarters (FOR block head- quarters). Financial Proposal will be quoted in figures as well as in words. In case of any ambiguity in figure amount quoted in words will be considered. The price quoted of Tissue culture produced Breeder/G-3 Potato (Lady Rosetta) seed must be with respect to desired technical specification mentioned in proposal documents. Conditional proposal will not be accepted.
- 4.20 No claim will be entertained afterwards for any increase in market price or otherwise. Payment against Bill/Invoice shall be made only after the purchasers (beneficiary farmers) consent through DBT programme only. **No interest will be payable on the delayed payment.**
- 4.21 If any complaint is received from farmer regarding quality of the seeds and found correct after inspection then 10% amount of supplied seeds to concerned beneficiaries will be seized and shall result in forfeiture of EMD, blacklisting and legal action against the agency.
- 4.22 BHDS will release admissible subsidy directly under DBT on the basis of the total quantity of seeds found in the farmers plot during physical verification of the plot (subject to maximum mortality up to 5%).
- 4.23 The agency shall submit an affidavit from notary that "the agency has not been blacklisted by any State Govt./Union Govt. and no legal issues regarding planting material supply is pending in any court.
- 4.24 Participation for the empanelment process will automatically imply the acceptance, on all the terms and conditions of this notice for empanelment.
- 4.25 Quantum of Tissue culture produced Breeder/G-3 Potato (Lady Rosetta) seed to be supplied would be decided on the basis of the capacity of the agencies to supply as already declared by the agencies in their financial proposal forms.
- 4.26 Performance Security Deposit: The successful agency should have to deposit an amount of 5% (incl. GST) of the total seed supply cost as Performance security deposit through NEFT/RTGS/Bank Draft/Bank Guarantee (Issued by nationalized bank only) in favor of the Mission Director, Bihar Horticulture Development Society payable at Patna, Bihar. The security amount will be/shall be forfeited if the party/firm/company/organization fails to provide plants in stipulated time.

5. Disqualification

The reasons for the disqualification of the participating firm/company/organization are mentioned below:

- a. The quotations/response to the e-tender submitted/received after due date/time will be summarily rejected.
- b. The interested entity has made misleading or false representation in the firms, statements, attachments submitted in proof of eligibility.
- c. The e-tender is not accompanied by required documentation.
- d. The interested entity fails to provide clarification related thereof, when sought.
- e. The firm/company should provide/give the correct and true information while submitting the tender. In case of incorrect/false information found at any stage, the tender/bid will be cancelled, and legal action will also be initiated.
- f. The interested Entity is found to canvass, influence or attempt to influence in any manner, the qualification or selection process, including without limitation, by offering e-tender or other illegal satisfaction.
- g. Notwithstanding anything written above or elsewhere, the e-tender may disqualify the Interested Entity without assigning or disclosing any reason thereof.
- h. Any change in the Annexure format specified in the RFP/E-proc2, may cause rejection of the bid.
