For the holistic development of horticulture in the state of Bihar, Bihar Horticulture Development Society (BHDS), Bihar, Patna invites e-tender from interested Govt./Semi Govt. organizations/private agencies for empanelment of 1 years to ensure timely availability of Premium Quality packaging material for Strawberry to the farmers of the state of Bihar.

Applicants may upload/submit their tender along with all required documents for technical qualification through the online portal <https://eproc2.bihar.gov.in>. Financial proposals should also be proposed on that portal separately.

Note: For a product to meet “Indian packaging / IIP-relevant” standards of quality & shelf life, typically:

1. Packaging must be food-grade and appropriate for product (material, sealing, barrier properties).
2. Packaging must resist moisture, oxygen, light, pests etc as appropriate.
3. Storage, transport, handling conditions must not degrade product (temperature, humidity etc).
4. Labelling must clearly show manufacturing date, shelf life / best before / expiry date; also storage instructions (e.g., “store in cool & dry place”, “refrigerate after opening” etc)

2. BHDS rights:

- a. The Bidders participating in the tender will invariably be accepting all the terms and conditions of the tender. Non-compliance with any terms and conditions may cause rejection of the bid.
- b. **In case, any confusion/dispute occurs due to different interpretations of the statement mentioned in the tender document, the decision of the Mission Director, BHDS shall be final and binding upon all concerned parties.**
- c. BHDS reserves the right to increase or decrease the quantity, negotiate, accept, or reject the proposal without assigning any reason thereof.
- d. The evaluation committee may negotiate with the price of L1, if needed in the interest of farmers. The negotiated price after the approval of competent authority will be final and applicable to the whole State of Bihar under the schemes mentioned.
- e. Evaluation will be done according to the terms and conditions cited in proposal documents under the governance of BFR, 2005.
- f. Cost of Packaging Material will be paid under DBT programme after **verification of quality/quantity of Packaging Material**. The admissible subsidy will be released through CFMS portal by the ADH concerned.
- g. Notwithstanding anything contained in the RFP, the Mission Director, BHDS, Patna reserve the right to accept or reject any proposal and annul the empanelment process and reject all proposals at any time without any liability or any obligation for such acceptance, rejection or

annulment and without assigning any reasons thereof.

- h. The Mission Director BHDS, Patna also reserves the right to reject any or all proposals if:

At any time, a material misrepresentation is made or uncovered: or, the bidders do not provide, within the specified time, the supplemental information/any additional information it may find necessary or require clarifying, supplementing or authenticating the Bid sought by Mission Director Horticulture, Bihar, Patna. Any request for clarification (s) and all clarification (s) on response thereto shall be in writing.

- i. **For any query/ confusion related to the tender document must be asked in the pre-bid meeting.** The pre-bid document proceeding will be part of the tender document. Any query/ concern raised after the pre-bid query date will not be entertained.
- j. **After final selection, the chosen agency must submit samples of the packaging materials for Strawberry to BHDS for approval by competent authorities.**

3. Evaluation:

- 3.1 Prior to evaluation of Proposals, the BHDS will determine whether each Proposal is responsive to the requirements of the RFP. A Proposal shall be considered responsive only if:

- a) It is received in the specified format.
- b) It is received by the due date including any extension thereof.
- c) It contains all the information (complete in all respects) as requested in the RFP.
- d) It does not contain any conditions.
- e) It has paid Rs. 100,000/- (Rupees One Lakh) as Earnest Money Deposit (EMD) only through online mode (NEFT/RTGS)

The proposal not found responsive to the requirements of the RFP, shall be rejected.

- 3.2 Technical Evaluation: The Technical Proposals will be opened first** and will be evaluated by the evaluation committee constituted at the society. Evaluation of the technical proposal shall be carried out by a committee constituted by the Society, which shall look into Eligibility criteria, compliance of specifications and other Terms & conditions for Empanelment. **Only those bidders qualifying through the Technical Bid will be considered for financial evaluation.**

- 3.3 Financial Evaluation:** At the second stage, **Financial Proposal of only technically acceptable agency will be opened**, for further evaluation.

4. General terms and conditions for Empanelment in BHDS: -

- 4.1 Proposal should be submitted only through online e-tender on website: <https://eproc2.bihar.gov.in>
- 4.2 Proposal submitted without relevant papers/documents will be rejected.
- 4.3 Telephone No./Mobile No./Email and Full Address of the applicant must be mentioned in the proposer Information sheet (Annexure II)
- 4.4 The packaging material for Strawberry shall have to be made available at the premises of districts of the Bihar state. No other charges such as Octroi, Packing, Forwarding, Freight, Insurance, Loading and Unloading, Clearance etc. will be allowed.
- 4.5 In case of any disagreement or dispute arises, both parties shall make every effort to resolve the issues amicably by direct negotiation, if the issue still persists, shall be settled under the Court of Law within its jurisdiction at Patna.
- 4.6 The agency shall have full responsibility to timely deliver the Premium quality packaging materials of Strawberry to beneficiaries of the schemes as the final work orders being given by DHO (District Horticulture Officer). Performance security deposit can be forfeited in case of non-performance of the contract and if time limits indicated in the work order are exceeded.

- 4.7 Strawberry packaging material should be as per the quality specifications mentioned in the proposal documents. **Failure to supply as per the quality specifications shall result in for forfeiture of EMD, blacklisting and legal action against the agencies.**
- 4.8 The BHDS is free to evolve strong punitive measures against erring agencies to safeguard the interests of farmers in order to ensure proper utilization of public funds.
- 4.9 **Financial Proposal** will be quoted in number as well as in words. In case of any ambiguity in quoted in number, the amount quoted in words will be considered final. Any correction of entries and overwriting in entries may be rejected without any prejudice.
- 4.10 EMD will be part of Technical Proposal only.
- 4.11 EMD of INR 100,000(Rupees One Lakh only) through online mode NEFT/RTGS needs to be submitted on or before the submission of bid.
- 4.12 EMD of the technically unsuccessful bidders will be refunded after the rejection of their Proposal and will be retained from the technically successful proposers till the submission of security deposit.
- 4.13 The **Technical Proposal** along with all required documents for technical qualification should be uploaded/submitted through online e-tender on website <https://eproc2.bihar.gov.in>. **Financial proposal should also be proposed on that portal in prescribed form separately.**
- 4.14 **The price proposed in the financial proposal must be inclusive of all taxes and freight** for destination etc. at district headquarters (FOR district headquarters). The price quoted for Strawberry packaging material must be with respect to the desired technical specification mentioned in proposal documents. In the financial proposal stock availability of Strawberry packaging Material must be mentioned.
- 4.15 Conditional proposals will not be accepted.
- 4.16 **Payment Terms:** 100% payment on delivery and acceptance by farmer. BHDS will release an admissible subsidy directly under DBT through CFMS 2.0 Portal on the basis of total number of Packaging material supplied to the farmers.
- 4.17 No claim will be entertained afterwards for any increase in market price or otherwise. Payment against Bill/Invoice shall be made only after the purchasers (beneficiary farmers) consent through DBT program by CFMS portal only. **No interest will be payable on the delayed payment.**
- 4.18 If any complaint is received from the farmer regarding quality of the packaging material and found correct after inspection then 10% amount of supplied packaging material to concerned beneficiaries will be seized and shall result in forfeiture of EMD, blacklisting and legal action against the agency.
- 4.19 Participation for the Empanelment process will automatically imply the acceptance, on all the terms and conditions of this notice for Empanelment.
- 4.20 **Performance Security Deposit:** The successful agency should have to deposit an amount of 5% of the total work order value as Performance security money in the form of Bank Draft/Bank Guarantee (Issued by nationalized bank only) in favor of the Mission Director, Bihar Horticulture Development Society payable at Patna, Bihar or through online mode (NEFT/RTGS). The security amount will be/shall be forfeited if the party/firm/company/organization fails to provide materials.

5. Disqualification

The reasons for the disqualification of the participating agencies are mentioned below:

- a. The quotations/response to the e-tender submitted/received after due date/time will be summarily rejected.
- b. The interested entity has made misleading or false representation in the firms, statements, attachments submitted in proof of eligibility.
- c. The e-tender is not accompanied by required documentation.
- d. The interested entity fails to provide clarification related thereof, when sought.
- e. The firm/company should provide/give the correct and true information while submitting the tender. In case of incorrect/false information found at any stage, the

tender/bid will be cancelled, and legal action will also be initiated.

- f. The interested Entity is found to canvass, influence, or attempt to influence in any manner, the qualification or empanelment process, including without limitation, by offering e-tender or other illegal satisfaction.
- g. Notwithstanding anything written above or elsewhere, the e-tender may disqualify the Interested Entity without assigning or disclosing any reason thereof.
- h. Any change in the Annexure format specified in the RFP/E-proc2, may cause rejection of the bid.**
